At this time Resolution No. 2019-028 was read as follows:

WHEREAS, the Authority accepted proposals for the following services – RAD Grant Improvements to the Senior Buildings, on or before, Thursday, November 21, 2019 at 1:00 PM.; and

WHEREAS, All services must be in accordance with the existing laws, rules, orders, directives and regulations governing these services and supplies; and

WHEREAS, the Authority accepted bids from:

WHEREAS, pursuant to the Request for Proposals and HUD procurement regulations, the proposals were reviewed and scored by the Authority's Review and Evaluation Committee; with Kitchen Classics LLC. proposal being scored the highest.

NOW, THEREFORE, BE IT RESOLVED that the Authority hereby awards a contract for said services to **Kitchen Classics LLC**, as recommended by Counsel after review of legal requirements and in accordance with HUD regulations.
