NOW, THEREFORE, BE IT RESOLVED that the Authority hereby awards a contract for Special Legal Services for Tenant Issues to Fitzpatrick & Waterman for an amount not to exceed \$15,000.00 (Contract Fee), in accordance with HUD regulations.

Mr. Capizzi informed the Board that he begins the dial up with the new director of the HMFA. She assures him that there won't be any road blocks from her perspective.

Mr. DiVincent informed the Board that some repairs are being done while waiting for the closing to be done.

Commissioner Martorony question not receiving the weekly report, Mr. DiVincent informed him that there was nothing new to report, he can only send copies of e-mails from WNC.

Commissioner Martorony express his concern about not getting the reports since he has requested them in multiple occasion. Commissioner Martorony would like for everyone in the Board to received the reports weekly showing all correspondence between Mr. Capizzi, Mr. Katchen and Mr. DiVincent and WNC, including the investors.

Commissioner Martorony would like to see a letter send to WNC and their investor saying time is up since our relationship with them was for 15 years only and after that we have the right to buy out.

Mr. DiVincent agreed to keep the Board informed at all time by sending weekly reports to all commissioners.

At this time Mr. DiVincent asked if there were any corrections, additions, comments or questions. There were none.

At this time Commissioner Fernandez made a motion to adjourn and Commissioner Gomez seconded.
