At this time Mr. DiVincent referred to item # 3 A - Minutes of Previous schedule meeting dated October 19, 2020. Board was asked to approve as presented. Asking for a motion to accept as presented. At this time Commissioner Martorony asked Mr. DiVincent if he had received an explanation from the Audit explaining how he had made that error for the past 10 years and how long would it take for the audited to give an explanation. Mr. DiVincent told Commissioner Martorony that 2018-2019 are corrected already.

Commissioner Martorony would like to know when this error first happened and he would like an explanation from the Audited himself. Mr. DiVincent informed Commissioner Martorony that he would invited him for the next meeting.
